

PETITION TO THE BOARD OF COMMISSIONERS OF CARBON COUNTY  
FOR THE CREATION OF A BRIDGER AREA PARK & RECREATION DISTRICT  
PURSUANT TO §7-11-1003, MCA

1. The Petitioners intend to request the Board of Commissioners of Carbon County, Montana, to present to the electors residing within the District Area described below, the question of whether to create a Park & Recreation District, pursuant to Title 7, Chapter 11, Section 1003, of the Montana Code Annotated, and further described below shall be imposed upon the District Area. If forty percent of the registered electors and or landowners who reside within this Petition, then the Commissioners may present the question to the voters.
2. The creation of the proposed district is to enhance the local parks and recreation available to the community;
3. The proposed district boundary, as more particularly described in Exhibit "A" hereto, using the same boundaries as the Bridger School District;
4. The proposed method of financing is a maximum property tax mill levy that could be levied on property owners within the boundaries for the operation of the district would be nine (9) mills;
5. The proposed number of members of the county park district commission would be three (3) as set by the County Commissioners initially, and then elected thereafter;
6. NOW, THEREFORE, THE UNDERSIGNED, who constitute at least 40 percent of the registered electors and or landowners residing in the proposed district boundary described in Exhibit "A" hereto, respectfully request the Board of County Commissioners of Carbon County to proceed with the creation of a county park district titled, Bridger Area Parks and Recreation District.
